◆ The members holding shares either in physical form or in dematerialized form as on the cut-off date 13th November 2017 may cast their vote electronically on the business as set out in the notice of the EGM through the Electronic voting system provided by CDSL from the place other than venue of the EGM (Remote E-voting).

◆ All the members are informed that:-

- The business as set out in the notice may be transacted through voting by electronic means;
- The remote e-voting shall commence on Thursday, the 16th November 2017 at 9.00 A.M to Sunday, the 19th November 2017 at 5.00 P.M;
- The remote e-voting shall end on Sunday, the 19th November 2017 at 5.00 P.M.;
- The cut-off date for determining the eligibility to vote by electronic means or at the EGM is, 13th November 2017.
- The e-voting shall not be allowed beyond 19th November 2017 at 5.00 p.m. The e-voting module shall be disabled by CDSL for voting thereafter.
- Once the vote on a resolution is cast by the members, it cannot be changed subsequently.
- The facility of voting through ballot paper will be made available at the EGM for the members present at the meeting. Members who have cast their vote by e-voting, prior to EGM may also attend the EGM but shall not be entitled to cast their vote again at the EGM.
